We will advertise your vehicle in magazines, internet, & on our website. **Note: Your vehicle must be removed from any existing advertisement as it will immediately be re-advertised through EuroMasters.**

Before bringing your vehicle to us make sure it is clean, detailed and ready-to-show  
**Note: We can provide these services for you. Consult your salesperson for details...**

Before your vehicle is displayed in our showroom it must be free of all mechanical and cosmetic problems. For example: paint, interior, bad tires, wheel bearings, transmission, engine, or any drivability problems. Items such as check engine lights and other dash warning lights must also be corrected. EuroMasters offers full in-house Parts, Service, Paint, & Upholstery departments to assist you with any necessary repairs

To make your vehicle more attractive and saleable, bring with you all service records and any current warranty agreements.

We are to retain the unsigned title if not held by the lien-holder as required by state law. If your vehicle has a lien holder, then we would require the lien-holder information with account number.

In an effort to properly market and ultimately sell your vehicle, it will be displayed in our showroom, outside front of building, at special events & car shows.

## 30-DAY CONSIGNMENT SALE

The sole purpose of this agreement is to sell your vehicle and to pay you the proceeds in the amount agreed upon under the terms of this agreement. If at the termination of this agreement the vehicle is not sold, EMCC shall return the vehicle to the Seller, or at the option of both the Seller and EMCC, enter into a new agreement. Refer to details on page 4.

If the vehicle is sold by the consignee during the term of this agreement, the money due the Seller shall be disbursed within 15 days after the date of sale. As used in this agreement, a 'Sale' occurs when the consignee either (A) receives the purchase price or (B) when the purchaser takes delivery of the vehicle, whichever occurs first.

Please Note: EMCC may or may not have insurance coverage for your vehicle. It is the Seller's responsibility to provide adequate insurance to cover any accidental loss or damage of the vehicle.

**Power-of-Attorney:** In the event the vehicle is sold, EMCC shall have the right to sign the Seller's name on any and all documents required to complete the transaction.

## 30-DAY CONSIGNMENT SALE

A parts & labor list shall be made available to seller as required repairs in order to sell the vehicle.

Repairs are to be paid immediately after the job is finished. The difference between the Agreed Amount less any outstanding liens shall be paid to the Seller after sale is completed.

**Seller's Initials**> \_\_\_\_\_ if Seller prefers to receive the Agreed Amount in the form of a 10% monthly interest payment with the Agreed Amount paid in full 12-Months from the date of sale.

If after 30-days the vehicle does not sell, then this agreement shall automatically re-new for an additional 30-day period with a 5% reduction per month in the seller's price. If Seller does not wish to renew the automatic agreement, then Seller must then provide in writing to EMCC of his or her intention to terminate the agreement anytime prior to the termination date.

The consigned vehicle is delivered to EMCC in trust for the exact terms set forth in this agreement. EMCC agrees to receive this vehicle and not to permit its use for any purpose other than contained within this agreement without the express written consent of the Seller. Further, the vehicle shall never be driven without an EMCC representative present.
