We retain exclusive right of sale while the vehicle is on consignment. You may refer prospects to us, but agree not to advertise so as to compete with us.

We will advertise your vehicle on the internet and on our website. **Note: Your vehicle must be removed from any existing advertisement as it will immediately be re-advertised through EuroMasters.**

Before bringing your vehicle to us make sure it is clean, detailed, and ready to show
Note: We can provide these services for you. Consult your salesperson...

Before your vehicle is displayed in our showroom, it must be free of all mechanical and cosmetic problems. For example, paint, interior, bad tires, wheel bearings, transmission, engine, or any drivability problems such as check engine lights and other dash warning lights after which EuroMasters shall become responsible for its Warranty!

EuroMasters offers full in-house Parts, Service, Paint, & Upholstery departments for any necessary repairs

We are to retain the unsigned title if not held by the lien-holder as required by state law. If you do not have the title, we would require the duplicate or lien-holder information with account number.

Customers requesting a test drive shall always be accompanied by a licensed salesperson

If at the termination of this agreement the vehicle is not sold, the consignee shall return the vehicle to the Seller, or at the option of both the Seller and Consignee, enter into a new agreement. Refer to details on page 4.

If the vehicle is sold by the consignee during the term of this agreement, the money due the Seller shall be disbursed within 10 days after the date of sale. As used in this agreement, a `Sale' occurs when the consignee either (A) receives the purchase price or (B) when the purchaser takes delivery of the vehicle, whichever occurs first.

Please Note: Seller may or may not have insurance coverage for your vehicle. It is the Seller's responsibility to provide adequate insurance to cover any accidental loss or damage of the vehicle.

The consigned vehicle is delivered to the consignee in trust for the exact terms set forth in this agreement. The consignee agrees to receive this vehicle in trust and not to permit its use for any other purpose other than contained in this agreement without the express written consent of the Seller. Further, your vehicle shall not be driven without an EMCC representative present.

Please Note: Make certain to remove all of your personal belongings before leaving your vehicle as EMCC cannot be responsible for any lost articles.
